



Terms of Use for Patient Education

These Terms of Use for Patient Education (these “Terms of Use”) govern use of patient education materials provided by an authorized representative of SelectHealth, Inc. (“SelectHealth”) to a SelectHealth network provider (“Provider”) for the purpose of permitting Provider to redistribute the materials to Provider’s patients (“Patient Education”). SelectHealth and Provider may be referred to in these Terms of Use individually as a “Party,” and collectively as the “Parties.”

THESE TERMS OF USE ARE A LEGAL CONTRACT BETWEEN PROVIDER AND SELECTHEALTH. BY DOWNLOADING, REPRODUCING, DISPLAYING, DISTRIBUTING, OR OTHERWISE USING PATIENT EDUCATION, PROVIDER AGREES TO THESE TERMS OF USE. IF PROVIDER DOES NOT AGREE TO THESE TERMS OF USE, THEN PROVIDER MAY NOT DOWNLOAD, REPRODUCE, DISPLAY, DISTRIBUTE, OR OTHERWISE USE PATIENT EDUCATION.

1. PATIENT EDUCATION LICENSE

1.1 Definitions.

- A. “Approved Purpose” means promoting the health and wellness of Provider’s patients.
- B. “License Period” means the twelve-month period beginning on the date Provider receives the applicable Patient Education from an authorized SelectHealth representative.

1.2 **License.** Subject to these Terms of Use, and Provider’s compliance therewith, SelectHealth hereby grants to Provider, and Provider hereby accepts from SelectHealth, a limited, non-exclusive, non-transferable, revocable license to download, print, reproduce, and distribute Patient Education to Provider’s patients solely for the Approved Purpose during the applicable License Period (the “License”). The License does not include the right to sublicense.

1.3 **No Obligation.** Nothing in these Terms of Use requires SelectHealth to provide, or to continue providing, Patient Education to Provider. And Provider acknowledges and agrees that SelectHealth may stop providing Patient Education to Provider at any time and for any reason (or no reason) at SelectHealth’s sole discretion.

2. **EDUCATION GUIDELINES.** From time to time, SelectHealth may provide guidelines to Provider concerning the appropriate use of Patient Education (“Education Guidelines”). In addition to these Terms of Use, Provider will comply with the latest version of Education Guidelines received from SelectHealth in connection with using Patient Education under the License. In the event of a conflict between these Terms of Use and any Education Guidelines, these Terms of Use will govern.

3. **MODIFICATIONS.** Provider will not modify, translate, or create derivative works of Patient Education without the express written consent of an authorized representative of SelectHealth’s legal department in each instance.

4. **UPDATED VERSIONS.** SelectHealth may, but is not required to, provide Provider with an updated version of Patient Education at any time during the License Period. The License applies only to the most-recent version of Patient Education provided by SelectHealth. Upon receiving an updated version of Patient Education from SelectHealth, Provider will stop copying, displaying, and distributing previous versions of the applicable Patient Education.

5. **COPYRIGHT NOTICE.** Provider will not remove or alter any copyright notice contained in Patient Education. Additionally, Provider will place on Patient Education any additional copyright notice or acknowledgement provided by SelectHealth.

6. **OWNERSHIP AND RESTRICTIONS.** As between Provider and SelectHealth, SelectHealth owns and retains ownership of all Patient Education, all intellectual property or other proprietary rights in or to Patient Education, and each copy, modification, or derivative work of Patient Education made by SelectHealth, Provider, or any third party. SelectHealth licenses, but does not sell, Patient Education to Provider under the terms of this Agreement. Provider will not use Patient Education in any manner derogatory to SelectHealth or inconsistent with SelectHealth’s ownership of Patient Education. SelectHealth retains all rights in Patient Education not expressly granted to Provider in these Terms of Use.

7. **NO ENDORSEMENT.** SelectHealth does not endorse, and Provider will not state or imply in any form or medium that SelectHealth endorses, Provider or any Provider product or service. Provider will not use SelectHealth’s trade name or logo as a trademark, service mark, or brand for Provider or for any Provider product or service. Except to the extent included in Patient Education distributed by

Provider under the License, Provider will not use SelectHealth's name or logo in any advertisement, marketing materials, publicity, news release, or public announcement.

8. **TERMINATION.** SelectHealth may terminate the License by written notice to Provider if either (or both) of the following happens: (a) if Provider fails to perform any material obligation set forth in this Agreement or (b) if SelectHealth determines, in its sole discretion, that Patient Education presents a risk to the health or safety of any person. All rights granted to Provider under these Terms of Use immediately terminate upon the expiration or termination of the License.
9. **NO WARRANTY.** SELECTHEALTH PROVIDES AND LICENSES PATIENT EDUCATION TO PROVIDER ON AN "AS IS" BASIS, WITHOUT WARRANTY OR REPRESENTATION OF ANY KIND, AND SELECTHEALTH HEREBY DISCLAIMS ALL EXPRESS AND IMPLIED WARRANTIES CONCERNING PATIENT EDUCATION, INCLUDING WITHOUT LIMITATION THE IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, MERCHANTABILITY, TITLE, AND NON-INFRINGEMENT.
10. **MEDICAL JUDGMENT.** Patient Education is not a substitute for independent medical judgment. Provider and its staff (employees, contractors, and volunteers), patients, and customers are solely responsible for their professional, business, and healthcare decisions. Provider and its staff (employees, contractors, and volunteers), patients, and customers assume all responsibility and risk for determining when and whether to rely on Patient Education.
11. **LIMITATION OF LIABILITY.** IN NO EVENT WILL SELECTHEALTH, OR ANY OF ITS SUBSIDIARIES, AFFILIATES, FACILITIES, DIRECTORS, OFFICERS, EMPLOYEES, AGENTS, OR ANY OF THEIR RESPECTIVE SUCCESSORS OR ASSIGNS, BE LIABLE TO PROVIDER FOR SPECIAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE, INCIDENTAL OR OTHER INDIRECT DAMAGES, LOSSES, OR EXPENSES. THIS LIMITATION APPLIES TO ANY LIABILITY, INCLUDING LIABILITY ARISING IN TORT OR CONTRACT, AND EVEN IF SELECTHEALTH HAS BEEN ADVISED IN ADVANCE OR IS AWARE OF THE POSSIBILITY OF THAT LIABILITY. IN NO EVENT WILL SELECTHEALTH'S TOTAL LIABILITY TO PROVIDER UNDER THIS AGREEMENT EXCEED THE AMOUNT OF \$1,000.
12. **INDEMNIFICATION.** Provider is liable for, indemnifies, and holds SelectHealth harmless from, any claim, lawsuit, action, and legal expense arising from or relating to Provider's use, reproduction, display, distribution, publication, or reliance on Patient Education.
13. **INJUNCTIVE RELIEF.** Provider acknowledges that any breach of the licensing provisions in these Terms of Use, and any unauthorized use of Patient Education, will result in damage to SelectHealth not adequately redressed by monetary damages and legal remedies alone. Accordingly, if Provider breaches any licensing provision of these Terms of Use or engages in unauthorized use of Patient Education, SelectHealth will be entitled to injunctive and other equitable relief without requirement of posting bond, including, without limitation, preliminary and permanent injunctions and specific performance. In addition to injunctive relief, SelectHealth may pursue any right or remedy under these Terms of Use or applicable law.
14. **ASSIGNMENT.** Provider may not assign or transfer any of its rights or obligations under these Terms of Use without SelectHealth's prior written consent, and Provider's attempt to so assign or transfer is null and void and is a material breach of these Terms of Use. These Terms of Use bind and benefit the Parties' successors and permitted assigns and transferees.
15. **GOVERNING LAW; VENUE; ATTORNEYS' FEES.** Utah laws, excluding its conflict-of-law provisions, govern this Agreement, and both Parties submit to the exclusive jurisdiction of state and federal courts in Utah. The prevailing Party in any litigation proceedings is entitled to recover its reasonable attorneys' fees, other fees, and costs incurred in the litigation, in addition to any other relief to which that Party may be entitled.
16. **RELATIONSHIP; THIRD PARTY BENEFICIARIES.** The Parties are independent contractors, and these Terms of Use do not constitute — and must not be construed to create — a partnership, agency, joint venture, or employment relationship. Nothing in these Terms of Use gives one Party the right, power, or authority to bind the other. These Terms of Use do not create any right in, or inure to the benefit of, any third parties.
17. **MISCELLANEOUS.** These Terms of Use, together with the then-current Education Guidelines, contain the entire agreement and understanding between the Parties relating to the subject matter of these Terms of Use and supersede all prior agreements, understandings, and representations relating to that subject matter. SelectHealth objects to any and all conflicting or additional terms proposed by Provider (including terms in any purchase order or other document provided by Provider), which are expressly rejected and do not apply to Provider's use of Patient Education. The Parties may amend these Terms of Use only in a written document signed by both Parties. No failure by either Party to enforce or exercise any right under these Terms of Use constitutes a waiver. If a provision of these Terms of Use is invalid or unenforceable, then the remainder of the Terms of Use will remain in full force and effect. All remedies provided in these Terms of Use, at law, or in equity, are cumulative and do not limit a Party's other available rights or remedies. Each section heading in these Terms of Use is for convenience only and does not modify or restrict any of these Terms of Use.
